

**SPECIAL MEETING OF STANLEY VILLAGE COUNCIL**

1 **ROOF - CIBC BUILDING**

Council agreed to go with the price of \$16,433.50 including tax to install a new pitched asphalt roof on the CIBC building. This quote was from Tamarack Lane Builders (C/O Darrell Hood).
