- 12 RESULTS OF SPECIAL MEETING - SEWAGE USER RATES -- a problem arose this week over at the Post Office as they lost their toilet facilities. Plumbers came up from Fredericton and inspected the situation. It was originally thought that they may never have been connected to sewage, but that was ruled out, and it was discovered that the two basins in the area were full of sand because of flushing of Stanley Hill. Any plans concerning changes in Sewage User Rates were postponed until next meeting.

Councillor Barb MacDonald agreed to represent Council at this hearing. Clerk reported that the appraiser, Jim McCoomb was up and appraised the building. Councillors Freda Hood and Barb MacDonald suggested that possibly a Senior Citizen Apartment or Bachelor Apartment would be a continuous source of Revenue, but Council felt that such a decision would have to be made at a later date.
